**ATTN EMPLOYERS** – This chart shows how much each worker will earn based on the services they provide and your county of residence. PPL tries to capture as many eligible tax breaks as possible for your worker. The taxes for these wages will automatically be withheld by PPL, based on the Family Relationship Form submitted in your worker packet to PPL. A list of the tax rates is noted at the bottom of this chart.

1. Pursuant to DDS Directive dated 12/23/2024, RCs must use standardized sub-codes. Accordingly, the sub-codes AR1, ASF1, ASMC1, ARC1, ACB1, ASOS1, AMP1 shall be consolidated as sub-code 1SO. Sub-codes AR2, ASF2, ASMC2, ARC2, ACB2, ASOS2, AMP2 shall be consolidated as sub-code 2SO. AR3, ASF3, ASMC3, ARC3, ACB3, ASOS3, AMP3 shall be consolidated as sub-code 3SO. 2. Pursuant to implementation of rate reform, the hourly rate for 1:2 and 1:3 moves to a per hour per individual rate. The 1:3 rate of \$12.79 per hour per participant exceeds the 1/1/2025 rate model benchmark of \$11.44 per individual per hour and will be held harmless during the applicable hold harmless period.

Transportation: Rates vary depending on the family/ family's authorization. Generally, the rate of reimbursement for mileage reimbursement is consistent with the California State Employee Personal Vehicle Mileage Reimbursement Rates as per GGRC Rate Setting Practices. Reimbursements for public transportation passes/trips are based upon the transportation authorities usual & customary rate/ fare for the specific authorized service.
