Timesheet deadline is the date a PSW must submit a completed timesheet to the CDDP or Brokerage office. A completed timesheet means a PSW has corrected any errors on the timesheet documented the progress/service notes, and signed the timesheet. If a PSW has an exception for eXPRS entry (not EVV only) the deadline for timesheet delivery is one business day earlier than the date indicated.

For all Pay Periods marked with an asterisk (*), Personal Support Workers have two (2) business days to submit their timesheets instead of three (3) business days. These Pay Periods have shortened timelines in order to comply with the Oregon Home Care Commission Collective Bargaining Agreement.
